From September 2017 working parents of 3 and 4 year olds may be entitled to 30 hours of free childcare. The eligibility for the 30 hour free childcare is:

Both parents must be working – or if you are a single parent then you must be working.

Each parent earns, on average, a weekly minimum equivalent to 16 hours at National Minimum Wage or Living Wage.

Parents must have an annual income of less than £100,000.

You must live in England
